Review of the Professional Qualifications Directive: Publication of the revised Directive in the Official Journal of the European Union

Directive 2013/55/EU, which provides for the modernisation of Directive 2005/36 on the recognition of professional qualifications, was published in the Official Journal of the European Union on 28 December 2013. The revised Directive therefore came into force on 18 January and Member States will have until 18 January 2016 to transpose its provisions into national legislation. Directive 2013/55/EU is available in all EU languages on EUR-Lex website. The Commission will publish a consolidated text from the Directives 2005/36/EC and 2013/55/EC in the coming weeks.

Review of the Public Procurement Directive: the European Parliament endorses in first reading the Trialogue agreement

On 15 January 2014, the European Parliament adopted in first reading the revised Public Procurement Directive, as agreed with the Commission and the Council. The introduction of new criterion in the award procedure regarding "most economically advantageous tender" (MEAT) will allow public authorities to put more emphasis on quality, environmental considerations, social aspects or innovation while still taking into account the price and life-cycle-costs of what is procured. The new rules are also expected to cut administrative burdens and help smaller companies to bid by encouraging the division of contracts into lots. "Abnormally low bids" will be closely monitored in order to avoid social dumping and make sure that workers' rights are respected in all Member States.

Following formal adoption by the Council, expected in the coming weeks, the Directive will enter into force 20 days after publication in the EU Official Journal. Member States will then have 24 months to implement into national law the provisions of the new rules. In 2014, ACE will develop guidance to assist ACE Member Organisations to influence the implementation phase. MEPs back tool to help EU firms compete for public contracts in third countries

On 15 January 2014, the European Parliament approved plans for a tool to allow EU countries to prevent non-EU firms from bidding for public procurement contracts worth €5 million or more unless their home countries reciprocate by allowing EU firms to do likewise. The proposed tool, which could be used only with European Commission approval, should strengthen the EU's hand in trade talks with third countries. "We are not trying to shut off our market. We are trying to motivate other countries to open their procurement markets to our firms", said European Parliament rapporteur Daniel Caspary (EPP, DE). The tool could be used only for big public contracts (worth €5 million or more excluding

VAT) and those in which goods or services originating outside the EU make up more than 50% of the total value of the goods or services involved. It will apply to those countries which do not currently have an international agreement covering public procurement with the EU but exclude Least-Developed Countries. According to the Commission, 85% of EU public procurement markets are already potentially open to international bidders, compared to only 32% of public contracts in the USA and 28% in Japan. This position goes in the direction of the ACE response to a questionnaire from DG Trade regarding international procurement. Eurostat press release: Production in construction down by 1.1% in EU28

In November 2013, seasonally adjusted production in the construction sector fell by 0.6% in the euro area (EA17) compared with October 2013, and by 1.1% in the EU28, according to first estimates released today by Eurostat, the statistical office of the EU. In November 2013, production in construction declined by 1.7% in the euro area and by 1.6% in the EU28, compared with November 2012. Among the Member States for which data are available for November 2013, production in construction fell in seven and rose in eight. The largest decreases were observed in the Czech Republic (-5.6%), Romania (-4.9%) and the United Kingdom (-4.0%), and the highest increases in Slovenia (+9.6%), Poland (+3.9%) and Hungary (+3.0%). Public consultation on a European Area of Skills and Qualifications

The objective of this consultation, run by the European Commission, is to collect the views of stakeholders on the problems faced by learners and workers with regard to the transparency and recognition of their skills and qualifications when moving within and between EU Member States, on the adequacy of related European policies and instruments and on the potential benefits of developing a "European Area of Skills and Qualifications". The consultation addresses in particular the following issues:

- How to place a stronger focus on higher and more relevant skills?
- Further strengthening links between education/training, mobility and the labour market
- · Adapting to internationalisation trends
- Ensuring clarity of rules and procedures for the recognition of skills and qualifications for further learning

These packages aim to reduce the primary energy consumption of a building to less than 50 kWh/m2/year.
